Presenter: Erin Nathan, A Member of Simmons Perrine Moyer Bergmann, PLC in Cedar Rapids, IA

Erin Nathan works with business to provide advice and practice solutions on hiring and terminations, large-scale reductions in force, resolving wage and hour issues (e.g. which employees are "exempt"), creating and revising employment policies to reduce risk and implementing harassment prevention and other employee training programs. She also represents business if accused of discrimination or harassment, retaliatory discharge, ERISA violations, FMLA violations, wage and hour violations or breach of contract. Ms. Nathan handles matters in state and federal court, before the EEOC, the Iowa Civil Rights Commission and other state and local governmental agencies. She will discuss some of the common pitfalls employers face when dealing with exempt and non-exempt employees.
